How AML Global works

AML Global operates as a co-operative. By aggregating the buying power of its client fleet, AML Global can negotiate far lower per-unit prices for fuel than clients would otherwise get if they negotiated on their own. Being independent and debt-free, AML Global acts solely on behalf of its clients and is dedicated to negotiating the lowest possible prices. The greater our client fleet, the greater the discounts we can pass on.

The client benefits of joining AML Global

1, Economies of scale

By signing up to the AML Global fuel programme, operators join a fleet of hundreds of AML Global-served jets worldwide. The buying power that this affords AML enables it to negotiate substantial fuel discounts. AML Global passes these discounts on to the operator, after adding a facility of 3 per cent of the net cost of the uplift, i.e. before taxes and other fees.

2, Free access to contract fuel at the most competitive prices at locations worldwide

Fuel suppliers and resellers often demand security down payments before you can open accounts. To maintain multiple accounts with different suppliers therefore entails a significant financial burden. By joining AML Global, you not only get discounted prices, but you also avoid down payments, since AML Global takes the risk. This allows you free access to resellers and main suppliers around the world.

3, Time saving by close monitoring of fuel prices worldwide

AML Global is continually fed updated prices by all resellers and main fuel suppliers - weekly in the USA, and monthly elsewhere. This allows AML Global to research the most competitive prices from all suppliers instantly. Our clients value the saving of time that this represents.

4, Data capture

We log, record and analyse all client transactions and uplift data. We send our analysis to clients in the form of regular statements, showing location, volumes, prices and aggregated savings. This gives clients the knowledge they need in order to maximise the efficiency of future operations.

5, Worldwide pricelist

To aid our clients in determining tankering strategies, clients are able to download a worldwide fuel pricelist showing location (ICAO), price (USD/USG) and supplier information.



How AML Global works

The operator submits his itinerary and places his order with us either by telephone, e-mail, Skype, SMS message, fax or via the AML Global website. AML Global analyses the order and compares prices across all suppliers on the itinerary. Once the most efficient purchasing strategy is reached, AML Global advises the client on which supplier(s) to buy from at which airports. LFMN (Nice, France) airport, for example, is one of the busiest destinations for the AML Global fleet. It has numerous suppliers whose prices fluctuate continually. AML Global can tell its clients in advance which supplier has the lowest price on any given day.

Within minutes of the client submitting his itinerary and fuel requirements, AML Global places the order and issues the pilot with a fuel release via SMS and/or e-mail.

After uplift, the supplier bills AML Global at the discounted fuel price, and we in turn invoice the client plus a 3 per cent facility fee, based on the net cost of the fuel (before taxes and fees).
